Remarks

Packages to the following countries of destination are not accepted: countries not currently in the European Union and all European islands.

If the sender sends a parcel that exceeds the maximum weight (max. 40 kg for domestic and export parcels) and girth (3 m = 2x height + 2x width + 1x length) published by GLS, or which is inappropriately packaged, GLS reserves the right, after weighing and measuring the parcel (the system is unable to handle overweight and oversize parcels), to apply a surcharge or return the parcel to the sender. In this event the shipment fee already paid is not refundable.
