**GLS General Logistics Systems Slovenia, logistične storitve d.o.o.**

## 1. General Provisions

The following rules define the course and participation conditions of the prize game organized by **GLS General Logistics Systems Slovenia, logistične storitve d.o.o.**

The organizer of the prize game is **GLS General Logistics Systems Slovenia, logistične storitve d.o.o.**, Cesta v Prod 84, 1260 Ljubljana, Slovenia, Company Registration No. 1538217000, VAT ID: SI74531891 (hereinafter referred to as the *Organizer*).

The prize game is conducted in the territory of the Republic of Slovenia and takes place from **16 October to 31 October 2025**.

All participants who enter the prize game acknowledge that they have read, understood, and fully agree with these general terms and conditions by participating.

## 2. Purpose of the Prize Game

The purpose of the prize game is to promote the **GLS Pošlji paket** service. Advertising and participation in the prize game are carried out in accordance with regulations governing the advertising of products represented by the Organizer.

---

## 3. Participants

The prize game is open to all **natural persons with permanent residence in the Republic of Slovenia**.

Employees of the Organizer, their immediate family members (spouse, common-law partner, parents, children), and any other persons directly involved in organizing or conducting the prize game are **not eligible to participate**.

Each participant may participate in the prize game **only in their own name**. By participating, the participant confirms that all personal data provided are their own and that they agree to these rules.

## 4. Method of Participation

A participant may enter the prize game if they meet all of the following conditions:

4.1. Comment on the official Instagram or Facebook post about the prize game "Pošlji paket," describing what they are sending via **Posljipaket.si (GLS Pošlji paket)**.

- 4.2. Follow the **GLS Slovenia** Instagram profile.
- 4.3. Tag **five (5)** people in the comment under the post.

## 5. Participation Rules

- 5.1. The winner expressly agrees that their **name and surname** may be published on the official Instagram and Facebook pages of **GLS Slovenia** in connection with the prize game.
- 5.2. Participants must not advertise any products or services, use inappropriate or offensive language, or post any content that could be considered harmful or insulting to any person or institution.
- 5.3. Participants agree that they are solely responsible for the consequences of any statements or actions made during their participation in the prize game.

## 6. Prize

The prize is a **promotional gift – a towel featuring the Posljipaket.si logo**.

## 7. Prize Draw and Winner Notification

The prize draw will take place on **31 October 2025**.

The winner will be randomly selected from among all eligible participants who have met the conditions specified in Article 4. The draw will be electronically recorded or documented in written form.

The record of the draw will be stored at the Organizer's headquarters in accordance with these rules.

The results of the draw are final and **no appeals will be accepted**.

## 8. Prize Collection

To be eligible to receive the prize, participants must meet the conditions outlined in Article 3 and agree to these terms and conditions.

If selected as the winner, the participant must send the following personal details to **marketing@gls-slovenia.com** within **24 hours** of notification:

- Full name
- Street address, postal code, and city of residence
- Telephone number

The Organizer has up to **four (4) weeks** from the draw date to deliver the prize.

If the selected winner fails to provide accurate and complete information within the specified time, they will be deemed to have declined the prize, and the

Organizer will be released from any obligation to deliver it. In such cases, the prize will not be awarded.

Prizes are **non-transferable and cannot be exchanged for cash or other goods**.

The Organizer reserves the right not to award the prize if:

- The winner fails to meet the eligibility criteria;
- There is doubt regarding the authenticity of the provided information;
- It is determined that the participant acted contrary to these rules;
- The awarding of the prize is otherwise impossible or unlawful.

## 10. Limitation of Liability

The Organizer assumes no responsibility for:

- The (non-)functionality of social media platforms (Instagram, Facebook, etc.);
- The (non-)functionality of the GLS application;
- Other technical issues affecting participation;
- Any consequences participants may experience as a result of participating in the prize game or using the prize.

The Organizer reserves the right to amend the rules if required for technical, legal, or commercial reasons or due to public interest.

Any changes or updates will be announced on the Organizer's official website or social media profiles.

## 11. Personal Data Protection

The Organizer will collect and process participants' personal data — full name, telephone number, address, and e-mail address (hereinafter: *data*) — solely for the purpose of conducting the prize game and delivering the prize to the selected winner.

During the processing of personal data, the participant has the right to access, rectify, restrict, or delete all or part of their data, in accordance with applicable legislation, by submitting a written request to:

Participants have the right to object, to data portability, and to file a complaint with the relevant authority.

They may also request that the Organizer permanently or temporarily cease using their personal data for direct marketing purposes.

Consent to receive electronic communications may be withdrawn at any time, in writing or by e-mail to the above address.

The Organizer will retain personal data processed for direct marketing purposes until consent is revoked.

Data processed based on contractual or legal obligations related to the prize game will be retained for **six (6) years** following the conclusion of the prize game, or as otherwise required by law.

Personal data are processed solely by the Organizer's **Marketing Department** and will **not be shared with third parties**.

---

## 12. Documentation Retention

The Organizer will retain the following documentation:

- All materials related to the organization and execution of the prize game, including these rules, for **three (3) years**;
- Documentation related to winners (personal data notifications, tax records, etc.) will be stored in accordance with applicable accounting and tax regulations.

After the expiration of these retention periods, documentation will be destroyed in accordance with the Organizer's internal policies.

Any disputes arising from this prize game that cannot be resolved amicably shall be subject to the jurisdiction of the **Ljubljana District Court**.
